Agenda #1	Welcome and Introductions

Agenda #2	Organization updates
Discussion	 Justo gave an overview and discussed the formation of GC3 working groups, steering committees, and the backbone organization. Cyndi New shared Self Regional keep a health equity focus specific to maternal health. They will be hosting a Maternal Health Data Walk on January 26th Britney Mazyck shared that Community Initiatives is offering Flu vaccines. Justo C. shared an update on United Way's Resource Hub has served 293 individuals since opening. UW is offering HORP training in Greenwood, Abbeville, McCormick, and Saluda which includes education on loan modification and foreclosure prevention.

Agenda #4	Unconscious Bias
Discussion	 Justo confirmed the success of the Unconscious Bias Training that took place at the Self Regional Support Service Building on November 14th from 10 a.m 12 p.m. We reviewed post survey data that confirmed the improvement of awareness and strategies to unconscious bias in the community and workplaces.
